SHELTER SA OBJECTS

The Association is formed with the principal object of working towards benevolent relief of poverty, distress and disadvantage by individuals and families in South Australia by:

- Promoting and maintaining the right of people living on low incomes and in need of benevolent relief to access affordable, safe and secure long-term housing that they identify as appropriate to their needs.
- Promoting and maintaining the right of people living on low incomes and in need of benevolent relief to housing of a quality which enhances people's health, well-being, dignity and life opportunities.
- Promoting the benefits of public and community housing in the community for people living on low incomes and all spheres of government.
- Publishing, researching, collecting or otherwise disseminating information on matters
 relating to the provision of housing, particularly for people living on low incomes, for public
 benefit and the relief of housing poverty.
- Establishing, supporting, resourcing and coordinating non-government organisations and agencies with similar interests and objectives to the Association.
- Promoting opportunities for disadvantaged members of the community to access housing provision free from discrimination as a result of factors such as age, gender, ethnicity, health status or disability.
- Promoting and supporting consumer and community participation in decision making in relation to housing for people living on low incomes and to promote access to avenues of appeal across all housing tenures.
- Doing all such other things as may be incidental to the attainment of these Objectives.
- The Association is a non-profit organisation operating to achieve the above benevolent purposes.

CHAIRPERSON'S REPORT

I am pleased to present the 2021 Annual Report for Shelter SA following our challenging but successful year. We spent the first part of the last year focussing on our organisational and associate members and securing their support following the unexpected loss of our government funding.

The trust our members place in Shelter SA, the regard for our advocacy and our credibility is very important to us and we look forward to retaining and expanding these attributes. I thank our long term members and welcome our new members. I acknowledge the work you have done throughout the pandemic and the critical assistance you have provided to members of the community. Our strategic partnerships will be maintained and developed so that we can influence social outcomes while sharing our advocacy with our partners. We are also developing new relationships through our fee for service activities utilising the extensive skills and networks of Shelter SA.

We currently have a secure financial position that allows the ongoing development of strategies that will bring consistent and sustainable income to the organisation.

Fee for service income generated through our strategic partnerships is a key component of our vision for the future and I encourage you to speak with us about how we may add value to your organisation and your work.

Systemic advocacy in a political environment is one of Shelter SA's strengths, and the organisation has launched it's election platform leading up to the next South Australian election. Shelter SA keeps the housing affordability crisis on the public agenda, advocating for social housing, a fairer private rental system and ending homelessness.

The 2020-2021 financial year was an important year for Shelter SA which transitioned from a government funded operation, after the cessation of funding on 30 September 2020, to a self-funded association with a strong membership base and the initiation of new revenue streams including fee for service activities.

The Shelter SA Board of Directors and management are intent on securing the longevity of Shelter SA to continue to deliver exceptional outcomes for the housing and homelessness sectors.

For the 2020–2021 financial year, Shelter SA performed well against budget and has improved on it's strong cash position which will assist in our continued advocacy for fairer housing outcomes for South Australians who are living on low incomes and in housing need in the new financial year.

EXECUTIVE DIRECTOR'S REPORT

It is an exciting time to be working for Shelter SA and we are optimistic about our future. With a strong Board in place providing leadership and governance, Shelter SA is innovating and leading the way in developing a new, independent business model.

We have drawn on our experiences with National Shelter and other sources, tapped into staff skills and expertise and continued to work with our members to forge ahead to 2022.

The reach and impact of our work did not slow down during the last financial year and we remain focussed on our core business – working on housing systems, policy, legislation and advocacy – while we are committed to enabling the increased supply of social housing.

Through the pandemic we have continued to engage with our members and stakeholders, meeting the many new leaders among our member organisations, expanding our associate memberships and working with the new homelessness alliances.

Shelter SA undertook many public speaking engagements in the past year reaching hundreds of people across South Australia and I am frequently invited as a guest speaker to conferences, university lectures, workshops and other forums, reflecting our healthy profile and the growing awareness in the community of the need to address housing affordability and homelessness.



We have completed three major projects this year – our Empty Homes project looking at vacant residential properties in Adelaide, our first Moving On report looking at how residential tenancies end, and our Election Platform – there is information about each of them in this report. Our Homes4Good platform, in partnership with Cornerstone Housing, has grown to thirteen properties at the time of writing. Homes4Good provides housing for people and families who are waiting for social housing. We are looking forward to sharing exciting news with you about an expansion of the program to the regions and more community housing partners in the near future.

We were excited to launch our new social enterprise, Uniquely Adelaide, and have received excellent feedback from our first customers. We are currently speaking with employment and education providers, to explore how we can apply our skills in this area to people living with disadvantage, especially young people, through their journeys to learning and employment.

We have released our election platform, with the objectives of improving access to affordable, safe, secure and appropriate accommodation for people living on low incomes in South Australia and we are engaging with all the political parties and independents to share their commitments to housing and homelessness leading up to the 2022 election.

I thank the members of our Board for their strong commitment to a healthy future for Shelter SA and their excellent governance. Our Chairperson, Paul Astley, has shown extraordinary leadership during this time of change and I thank him for the time and experience he dedicates to Shelter SA. Thank you to our retiring Board Member, Joanne Fox, and our previous Board Member, Clare MacAdam, for the expertise and commitment they have provided to us.

I thank past staff members, Michelle Lindblom and Caitlin Smith, who we farwelled towards the end of 2020. I also acknowledge and thank our bookkeeper, Kelley Reay, for her services, assisting us to monitor our finances and provide financial reporting to our Board. Last but not least, thank you to our members and colleagues, for your support and encouragement, I am looking forward to a bright future for you and the citizens you serve, continuing to speak out about housing and advocating for a fairer society.












UNIQUELY ADELAIDE

ELECTION PLATFORM



Shelter SA has launched an Election Platform leading up to the 2022 State Election with the objective of seeking election commitments from all the parties and independents. The focus of the Platform is to improve the supply of social housing, housing affordability and reduce the number of South Australians experiencing homelessness.

The Platform is intended to add to the discussions we are already having about housing need and to start a conversation about strong, structural reform of our inclusionary zoning policy, to move away from the construction and sale of affordable housing towards social housing outcomes.

We are calling for an investment in social housing, better housing outcomes for children experiencing homelessness and a range of other measures to relieve the housing stress and poverty that exists in our State.
